



Peter Walter Stott

Stott is the chairman and CEO of Market Express, LLC, a regional transportation and logistics company, which is a portfolio company of Columbia Investments, Ltd. He is the President of Columbia Investments, Ltd. which was founded in 1983 and serves as the family office. In addition, he served as the vice chairman and a principal of the real estate private equity firm ScanlanKemperBard Companies from 2005 to 2010 and as CEO of that company from 2008 to 2010. Stott was co-founder and former president and CEO of Crown Pacific from 1988 to 2004. He was the founder and former Chairman and CEO of Market Transport, Ltd., 1969 – 2006; one of the largest “asset-based” transportation and logistics services companies headquartered in Oregon. Market Transport, Ltd. was acquired in 2006 by UTI Worldwide and subsequently, in 2015, by DSV Global Transport and Logistics.

Mr. Stott is a member of the board of directors for Omega Morgan, one of the Northwest’s leading providers of complex lifting, rigging and moving solutions and a board member of American Sentinel Insurance Company. Mr. Stott is a former board member of Gerding/Edlen Development Company, one of the nation’s leading real estate investment and development firms, River Point Farms, America’s largest onion grower, and Con-way Inc., which was the nation’s third largest less-than-truckload carrier. Con-way was sold to XPO Logistics for \$3.1 billion in October, 2015. He also is a former board member of Liberty Northwest Insurance Company, a Liberty Mutual Company.
